The AGM is an in person meeting only and will not be available telephonically or electronically.

The AGM is an important opportunity for members to:

- Receive updates on the Club's performance and key initiatives
- Review the financial statements for the past year
- Participate in the election of new Board members
- Share feedback and discuss the Club's direction for the future

MEMBERS:

A member of the Markham Soccer Club (MSC) is an individual registered as a soccer player with the Club. Members under the age of 18 must be represented by a parent/guardian. Only members in good standing have voting rights at the AGM.

Definition – A Member will be in good standing provided that the Member:

- a) Has not been suspended or expelled from membership, or had other membership restrictions or sanctions imposed;
- b) Has completed and remitted all documents as required by the Corporation;
- c) Has complied with the By-laws, policies, and rules of the Corporation;
- d) Is not subject to a disciplinary investigation or action by the Corporation, or if subject to disciplinary action previously, has fulfilled all terms and conditions of such disciplinary action to the satisfaction of the Board; and
- e) Has paid all required membership fees.

****All payments due on or before February 25th 2026 must be paid in full, on or before end of day February 25th. Members with overdue payments or unpaid balances to MSC as of this date will not be eligible to vote.****

VOTING:

- Regular Members who are 18 years or older may exercise one vote
- Regular Members younger than 18 years old may have one vote exercised on their behalf by a parent or guardian. Parents or guardians with multiple children registered with the Club may exercise one vote per registered child, while two parents of the same child may only cast one vote collectively
- Voting by proxy is not permitted
- Voting will take place manually via paper ballot in person only. You must be present to cast your vote
